If you are filing a 2011 income tax form and have..

- One child living with you and earned less than \$36,052*, you can get an EIC up to \$3,094.
- More than one child living with you and earned less than \$40,964*, you can get an EIC up to \$5,112.
- No children living with you, earned less than \$13,660 and are between the ages of 25 and 64, you can get an EIC up to \$464.

*Income limits for married workers are \$5,000 higher.
